Phyllis Saathoff is an accomplished executive with 25 years of service in the port industry. With a strong accounting and finance background combined with her operational leadership, Phyllis brings a proven track record to Port Freeport.

Saathoff began her maritime career at Port Freeport in 1992. She served as Managing Director, and then in April 2012, became the Interim Executive Port Director/CEO before joining the Port of Houston Authority in October 2012. Saathoff served in various capacities during her tenure at the Port of Houston Authority including, Chief People Officer and Deputy Executive Director of Corporate Affairs, she was responsible for public affairs, strategic planning, channel development, freight mobility and environmental affairs. Saathoff returned to Port Freeport in April 2016 as the Chief Executive Officer.

During her prior tenure at Port Freeport, Saathoff was successful in obtaining U.S. Army Corps of Engineers permit to deepen the Freeport Harbor Channel to 55 feet, and in financing and initiating the development of the Port's first container terminal. Saathoff received the Certificate of Excellence in Financial Reporting from the Government Finance Officers Association for 21 consecutive years.
