SUBJECT: Grazing Leases

Port Freeport currently has three grazing leases related to parcels 5,6,7 and 38. Each of the three leases were executed in 2018 after all options from the initial 1998 leases had expired. Evaluations were performed at that time with lease rates adjusted accordingly. The leases were then extended for a three year period in 2019 which expired on 6/30/2022 and the leases have converted to a monthly basis. Staff recommends extending the leases an additional three years at current rates.

SUBJECT: Tax Abatement Guidelines

Under Tax Code Chapter 312, tax abatement guidelines are effective for two years from the date adopted. The current Port Freeport guidelines were adopted on July 23, 2020 and thus need to be updated to consider new applications going forward. Applications submitted prior to the expiration of the current guidelines will be considered under the existing guidelines. Staff has reviewed the guidelines and state statute along with legal counsel and has suggested updates aimed at providing administrative and process clarity. After reviewing with the Finance Advisory Committee, staff will present to the full board for adoption.
