# **Port Salaries, Wages and Benefits**

Increase from 2024 forecasted \$987,028 or 18% - Budget \$6,563,145

## Budget includes:

- Fiscal year 2025 includes 4% increase in CPI/merit raises (FY 2024 5.27%)
- Filling four approved positions that are vacant, two new requests for Gantry Crane
   Technicians, and one new request for an Operations Manager
- \$40,000 in market adjustments
- 5% increase forecasted in group health, 10% increase in forecasted dental and vision premiums (renewal is January 1)
- Percent of group health to total wages and benefits 14.39%
- Assumes full participation in retirement plan
- Percent benefits to salaries and wages 35%
