

PORT FREEPORT EMPLOYER TWIC ESCORT SPONSORSHIP FORM



GENERAL REQUIREMENTS

In accordance with 33 CFR 101.514, it is the policy of Port Freeport that all persons seeking unescorted access to the restricted areas of Port Freeport maritime facilities must possess a valid Transportation Worker Identification Credential(TWIC), and be approved to enter by the Port Freeport before such access is granted.

The possession of a TWIC is required for individuals who need routine access to restricted areas in the course of their employment and due to the nature of their employment where escorting is not feasible. Persons seeking access to Port Freeport maritime facilities who do not have a TWIC, are not routinely employed at Port Freeport maritime facilities, have demonstrated a business need and are approved by Port Freeport to enter, may only enter restricted areas of Port Freeport maritime facilities with a Port Freeport approved escort.

In accordance with 33 CFR 101.105, escorting means ensuring that the escorted individual is continuously accompanied while within a restricted and/or secure area in a manner sufficient to observe whether the escorted individual is engaged in activities other than those for which the escort was granted. This means side-by-side continuous accompaniment in close proximity with constant visual contact.

SPONSORING EMPLOYER / TENANT

A sponsoring employer requesting TWIC escort privileges for a TWIC escort firm must submit this application to Protective Services at the Emergency Operation Center (EOC). If a tenant performs their own escorting, the firm shall complete this form, but will be exempt from TWIC Escort licensing fees.

SPONSORED TWIC ESCORTING FIRM

The sponsored TWIC escorting firm shall not be permitted to provide TWIC escort services until they occur a TWIC Escort Company License. All employee of the TWIC escort firm who perform escorting duties shall complete TWIC escort training provided by Port Freeport in accordance with 33 CFR Part 105.215 and licensed by Port Freeport as a TWIC Escort Company. TWIC escort companies shall abide by TWIC escort requirements within Port Freeport's Tariff.
